The first round counselling, consisting Phase I, Phase II, Common open round counseling and Second Common Open Round Counselling of CTS (Craftsmanship Training Scheme) for session 2020-21 and 2020-22, at HTI against advertisement, No. HEC/HTI /CTS/2020-06, dated: - 31.07.2020 has already been completed on 25.09.2020.

After successful completion of counselling on dtd: 25.09.2020, selected candidates pertaining to various disciplines/trades as per the scheduled, the following 79 (Nineteen) nos. of seats in different discipline and category wise is laying vacant for the Final Common Open Round Counselling, scheduled to be held on 09.11.2020 adhering the time limitations from 9.00 am to 12.00 pm only. After the Final Common Open Round Counselling date and time, if seats are still vacant then again Counselling may be conducted on 10.11.2020 adhering the time limitations from 9.00 am to 12.00 pm only, since the same day further official available time period, the merit list towards reported candidate's for final common open round counselling is to be prepared by HTI for their counselling and admission.

Final Common Open Round Counselling: -

- The Common open round counselling is scheduled to be held on 09.11.2020 and 10.11.2020 for CTS (Craftsmanship Training Scheme), strictly on merit basis with as per records of HTI Main Gate entry, attendance time from 9.00 am to 12.00 pm. Failing the time schedule no any candidate will be entertained for counselling.
- After 12.00 pm a merit list will be prepared discipline and category wise of all the eligible reported candidates and accordingly counselling will be done for the same.

• After successful completion of Common open round counselling no further counselling will be entertained to avoid the session delay.

<u>In Final Common Open-Round counselling Candidates are advised to go through the</u> following processes:

- No candidate will be allowed on any pretext/ ground after 12.00 pm on the scheduled date
 of counselling.
- Admission will be taken, strictly, discipline and category wise, on the basis of merit against the vacant seats among the eligible reported candidates at scheduled date and time.
- No claim will be entertained against filled up vacant seats.

Candidates have to bring the following documents in original for verification and two sets of self-attested photocopy at the time of counseling. Without following essential documents your candidature will not be considered: -

- a) Matriculation/10th pass certificate/ provisional certificate.
- b) Mark sheet of Matriculation or equivalent. (as a Date of birth certificate)
- c) Recent passport sized colored photograph 5 nos.
- d) Caste certificate [SC/ST/OBC (Non-creamy layer)] issued by a competent authority latest one.(If applicable)
- e) PWD (Person with disability) certificate (if applicable) issued by civil surgeon/competent authority.
- f) EWS certificate issued by a competent authority latest one. (If applicable)
- g) Certificate of being ward of HEC: employee/ Ex. employee/ Contract Worker, Hatia displaced/ Dependent of Diseased employee (If applicable).
- h) Aadhar card (UID).
- i) Receipt of payment for application fee (HTI copy of challan or Demand Draft).
- j) Self undertaking (Enclosed in application form).
- k) School leaving/Collage leaving certificate (last Institute/School/College attend)
