It manufactures and supplies capital equipments & machineries and renders project execution required for core sector industries. It has complete manufacturing set up starting from casting & forging, fabrication, machining, assembly and testing - all at one location backed by a strong design - engineering and technology team.

HEC invites applications for **one post of General Manager for its Heavy Machine Building Plant (HMBP)** from dedicated and committed professionals with a high degree of initiative and intuitive forward thinking.

The other details are as under:

- 1) **Scale of Pay:** Rs.43,200–66,000 (E7). Initial Basic Pay : Rs. 43,200/-
- 2) **Other Benefits:**
Besides basic pay, DA, statutory benefits like CPF, Gratuity etc, other allowances, Free Medical facilities for self and dependant family members, accommodation (as per availability) or HRA, Leave etc. are admissible as per the rules of the Corporation in force from time to time.
- 3) **Minimum Qualifications:**
Full time Degree Course in **Mechanical, Production, Metallurgy, Electrical or Electronics Engineering** with first Division (60% marks) or CGPA equivalent. For SC/ST candidates it is 55% or CGPA equivalent.
- 4) **Preferred Addl. Qualifications:**
 - a) Degree or Diploma in Business Management
 - b) Degree or Diploma in Production Management
- 5) **Maximum Age: 56 (fifty six) years** as on 01st December, 2015.
- 6) **Experience:**
 - a) Minimum **25 (twenty five) years** post qualification experience as on 01st December, 2015 in engineering industry.
 - b) Should have at least **3 (three) years** experience as **Head of Operation/Production** in a large engineering industry having minimum annual turnover of Rs.100 Crores.
 - c) Should have adequate exposure in Production Planning and Control, Maintenance, Quality Assurance, and Supply Chain Management in a large engineering industry.
 - d) Must have strong management, leadership, communication, analytical and interpersonal skills.
 - e) The candidates from other Companies (including PSU) must have completed **minimum three years service** in the immediate lower grade or equivalent.
 - f) The candidates from Private Sector are required to furnish details of annual audited report for the last **3 (three) financial years.**

7) **Internal candidates:**

Internal candidates who have completed at least **3 (three) years** in E6 scale and holding engineering degree or equivalent are eligible to apply.

There is no age bar for such internal candidates.

8) **Responsibilities :**

- b) Responsible for the profitability and viability of HMBP (Strategic Business Unit).
- c) Responsible for all aspects of management of the HMBP including production, planning, operations, monitoring and control, marketing & sales, supply chain management, financial management, collection of receivables, coordination with customers, other Plants of HEC, and all other responsibilities expected of a Profit Centre Head including HR & Personnel.
- d) Depending on the requirements/circumstances, the job responsibilities may be changed and the incumbent may be transferred to other area/s.

Reservation and relaxations will be allowed in accordance with Govt. of India directives for SC/ST/OBC (Non Creamy Layer) & Physically Challenged candidates provided a minimum 2 years of service is left.
