It has complete manufacturing set up starting from casting & forging, fabrication, machining, assembly and testing - all at one location backed by a strong design - engineering and technology team.

HEC invites applications for **one post of General Manager – Finance for its Head Quarter, HEC** from dedicated and committed professionals with a high degree of initiative and intuitive forward thinking.

The other details are as under:

- 1) **Scale of Pay:** Rs.43,200–66,000 (E7). Initial Basic Pay : Rs. 43,200/-
- 2) **Other Benefits:**
Besides basic pay, DA, statutory benefits like CPF, Gratuity etc, other allowances, Free Medical facilities for self and dependant family members, accommodation (as per availability) or HRA, Leave etc. are admissible as per the rules of the Corporation in force from time to time.
- 3) **Minimum Qualifications:**
Chartered Accountant (CA) / Cost and Works Accountant of India (ICWA).
- 4) **Maximum Age:** 56 (fifty six) years as on 01st December, 2015.
- 5) **Experience:**
 - a) Minimum **25 (twenty five) years** post qualification experience as on 01st December, 2015.
 - b) Should have at least **3 (three) years** experience as **Head of Finance** in a large Company / engineering industry having minimum annual turnover of Rs.100 Crores.
 - c) Should have adequate exposure in Financial Accounting, Cost Accounting, Project Financing, Taxation, Contract Accounting, Financial Concurrence on Expenditure Proposals, MIS Projections, and Cash Management in a large Company / engineering industry.
 - d) Must have strong management, leadership, communication, analytical and interpersonal skills.
 - e) The candidates from other Companies (including PSU) must have completed **minimum three years service** in the immediate lower grade or equivalent.
 - f) The candidates from Private Sector are required to furnish details of annual audited report for the last **3 (three) financial years.**

6) **Internal candidates :**

Internal candidates who have completed at least **3 (three) years** in E6 scale and holding requisite qualification or equivalent are eligible to apply. There is no age bar for such internal candidates.
