- 1. The offer is to be submitted in two parts:
 - 1st Part Techno-commercial Bid consisting the following:
 - (a) The layout design proposed for renovation covering floor design, lighting scheme, audio-visual system, furniture design etc The party may have to give power point presentation, if required.
 - (b) Acceptance to our Techno-commercial terms & conditions against the tender & scope of work.
 - (c) Earnest Money Rs 15,000/=.and Rs 200/= towards cost of tender document. Separate Pay Order/Demand draft for each amount to be submitted in favour of Heavy Engineering Corporation Limited payable at Ranchi.
 - (d) Details of similar work done by the party.
 - (e) Copy of latest IT return, PAN, Service Tax, VAT etc

2nd Part – Price Bid : As per the format of the scope of work.

2. Sealed tenders (Part -1 & Part -2) to be given in separate envelope and both to be put in a third envelope addressed to :

The tender should reach to the above address on or before the due date i.e.

2nd July'2010 5.00 PM.

- 3. Late receipt of tenders will not be allowed.
- 4. The 1st Part: Technical Bid will be opened on 3rd July'2010
- Offers should be submitted type written with out overwriting. The proposed design of the renovation of conference room is to be submitted in hard copy but may be asked to give a visual presentation, if required or submit soft copy of the same for acceptance/ modification, I f any.
- 6. Once the 1st Part i.e. techno-commercial bid is opened, it will be scrutinized at our end and the parties will be called for presentation / discussion on their offers. After qualifying through technical bid, 2nd part i.e. price bid will be opened.
- 7. Company does pledge itself to the accept whole or part of lowest or any tender and the rate quoted for supply.
- 8. The techno-commercial bid as well as the price bid will be as per the format of scope of work.
- 9. The price quoted should be firm and on unit rate as well as total amount which is to be mentioned both in figures and words. The rate should be inclusive of any taxes/duties, insurance charges, packing & forwarding and transportation, but there should be mention of percentage additions of all these costs over the basic price. The payment of statutory duties will be subject to documentary evidence.
- 10. The bills should be raised on the basis of actual measurement of completed work / units supplied.

11.Payment Terms:

- (i) No advance will be paid on issue of work order.
- (ii) 1st bill can be raised after completion of part (A)+(B).
- (iii) 2nd bill can be raised after completion of the entire work and the payment will be released within 30(thirty) days..
- (iv) 10% of total value of contract executed will be deducted from the above bills and the same will be paid on successful operation of the audio-visual system and other supplies after six months from the date of completion of the work and issue of completion/commissioning/no claim certificate by engineer-in-charge.
- (v) All the above bills must be supported by detail technical measurement in support of quantity of job executed and the same be certified by engineer-in-charge.
- 12. Work Completion/Delivery Time: One Month.

- 13. Validity of offer should be three months from the date of opening of technocommercial bid.
- 14.EMD Rs 15,000/= as submitted will be kept in case of successful tenderer and will be treated as security deposit till satisfactory completion of the work. The EMD in case of unsuccessful tenderer will be returned. No interest will be payable on EMD.
- 15. The time will be the essence of the contract. And the work should be completed within contractual time of completion. Otherwise:
 - (a) The customer (HEC) to recover a sum of 0.5% per week of delay from the price of supply /work done up to a maximum of 10% of the total contractual value as liquidated damage for the delay in completion or
 - (b) The customer may procure / work done from alternative sources at the risk & cost of the contractor or
 - (c) The customer may terminate the whole or part of the contract.
- 16. The work done / supplies will be duly inspected by the representative of the customer and bill will be cleared on the basis of acceptance of the work.
- 17. The tenderer would be solely responsible for compliance of all labour laws and other statutory obligation in connection with this work.
- 18.All the tenderer are required to submit the copy of latest income tax certificate, service tax, VAT registration etc.
- 19. The tenderer should have registration with HEC. If not, they should initiate the process of registration.
- 20 All other remaining commercial terms will as per our "General Terms & Condition of Works Contract "available in our website: www.hecltd.com or can be seen from our office in person.
