- 2. The firm must keep Validity Period of the offer for minimum 90 days from the Tender Opening Date (TOD).
- 3. Earnest Money (EM) for **Rs.70,000=00 (Rs. Seventy Thousand only)** to submitted alongwith Techno Commercial Bid.

EMD is to be accepted in the following forms:
