Method of submission of offer:

1. **Quotation to be submitted in TWO-BID System** i.e.
 - (a) **Techno commercial bid (Part I)**- This techno-commercial bid shall be conforming to all technical specifications, commercial terms and conditions,& price format with price column blanked (Un-priced) The price format should contain item wise list of items for which the price has been quoted.(Annexure A)
 - (b) **Price bid (Part II)** – This part shall comprise price format duly filled in (Annexure B). It has to be filled properly with permanent ink without any overwriting/correction in it.
2. Techno-commercial bid should be sealed in separate envelope super scribing as part-I & Price bid should be sealed in a separate sealed envelope super scribing as part-II with tender enquiry reference, date, due date of opening & tenderer's name & address on each envelope.
3. Both bids i.e. part-I & part-II has to be sealed in **one sealed envelope** clearly super scribing on the top of envelope tender reference no. with date, due date of opening & tenderer's name , address & "TWO BID" on it.
4. If offer is not submitted as per, "Method of submission of offer" explained as above then offer shall not be considered.



Qualifying Criteria:

1. **Validity of offer** should be minimum 90 days from the date of opening of tender. The offer with a lower validity period other than 90 days will not be acceptable and such offer shall be ignored without assigning any reason.

Commercial terms and conditions:

1. Offers to be submitted on FOR HMBP Stores basis. The rate quoted shall be inclusive of all packing & forwarding, freight and transit insurance charges. **If quoted Ex-Works then Freight Charges upto HMBP/HEC/RANCHI must be indicated, otherwise the offer may not be considered.**
2. The Price quoted by the tenderer should be exclusive of GST. The rate and nature of GST applicable should be shown separately GST will be paid to the seller at the rate at which it is liable to be assessed or has actually been assessed on the date of supply provided the transaction of sale is legally liable to GST and within the delivery period.
3. The rates quoted must be firm and the offers made must remain open for acceptance for minimum 90 days from the date of opening of the tender.
