

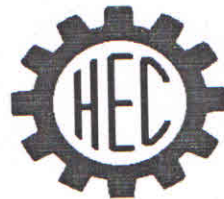

**CHAPTER-I**

1.1 Tender is invited for entering into rate contract for the period of two years at HMBP as per the details.

1.2 **Description of work**

Radiographic Test are required to be conducted as per the details and Drawing.

Item	Forging, Casting, Welded Joints

Average Thickness	65-170mm

**Note-**

1. The radiographic is to be carried out at HMBP/HEC Ltd Ranchi-4.
2. Radiography examination is to be carried out on Casting, forging and welded Joints of different production items.
3. Size of film: - Length 300mm, width 100mm.
4. Thickness of job: - 65 mm – 170 mm
5. Work Load: The Radiographic Work will be distributed on different dates depending on our requirement, minimum load will be around 2 exposures
6. Completion period of work: approx. 5 exposures per day of offered quantity
7. The radiographic exposed films and reports will be submitted to us and will be the property of HMBP/HEC Ltd Ranchi-4
8. The radiography is to be carried out as per procedure mentioned in ASME Sec. V, Article 2.
9. All Equipments, unexposed films, developer, fixer and technicians shall be provided by Service Provider.

11. Quality of Radiography, completion of radiography will be inspected by I/c CMTU/HMBP or his authorized representative.
12. Improper quality of radiographs will be re-radiographed by service Provider free of cost

1.3 **Submission of Tender**

The offer is to be submitted in Two Bid.  
The offer is to be submitted in two parts. Part I and part II.

Part I of the tender will comprise of Techno Commercial offer which shall contain / cover all terms and conditions, Tender fee, Earnest money deposit (EMD), Information regarding Schedule I & II and one copy of this tender document duly signed on each page. The part I of the tender shall also have the price format (Schedule-I) with blocks duly filled as "Quoted" against each head. The taxes & duties should be clearly spelt out in the techno commercial offer (Part - I).

Part-II of the bid will comprise of price format (Schedule-I) duly filled up by tenderer.  
Both the bids as Part-I & Part-II shall be in separate sealed covers clearly super scribing tender reference no. with date and Part I & Part II respectively.

Both envelopes i.e. Part I & II shall be enclosed in one envelope. This envelope shall also be super scribed on the top with tender reference no., date of opening of tender enquiry and indicating that both the parts (Part I And part II) are enclosed in the envelope.

**1.4 Eligibility Criteria :**

- a) Experience of similar work executed during the last three years. Details like value, clients to be mentioned by the Service Provider enclosing documentary evidence.
- b) All Equipments, unexposed films, developer, fixer and technicians etc.
- c) Permanent Account Number (PAN) of Income Tax Department in the name of the firm, GST Registration number, ESIC registration no/certificate, PF registration no etc is to be submitted.
- d) Status of Constitution and legal status of the service provider (individual, partnership, co-operative, society, registered firm etc.); existence of joint-venture or other tie-ups for technology, equipment, financial backing and/or project management is to be submitted.
- e) Details of Registration with specified agencies if any to be furnished.
- f) Availability of key personnel for supervision & management of the work or project to be spelt out.

**1.5 Price**

Price is to be quoted strictly in the format enclosed chapter-II Schedule -3 of this tender document. Price quoted should be firm without any deviation. L-1 will be decided on Package basis and Landed cost. The agreed price will remain firm through out the period of the contract.

**1.6 Acceptance of Tender**

Tender may be accepted in full or part. Any incomplete tender in any respect is liable to be rejected. The company is having right to reject any tender without assigning any reason for which no question can be asked anywhere.

- a) Earnest money** - Rs. 5,000/- (Rs. Five thousand only) in the form of D.D. in favour of HEC Ltd. Payable at Ranchi must accompany the tender. EMD shall be exempted for NSIC/SSI Units as per Government Guidelines on submission of documentary proof along with the offer.

The EMD of the unsuccessful tenderers will be refunded immediately after finalization of the contract on receiving a written request from the bidders. For successful tenderer the earnest money will be converted to the security deposit

- b) Security Deposit / Retention money** - shall be 10% of the contract value. In the event of non execution of the contract or withdrawal before expiry of the validity period the security deposit will be forfeited. The security deposit will be refunded within reasonable time of issue of completion / commissioning certificate against the request of the contractor and no claim certificate from the respective engineer/ executing department.

**1.7 Executing Authority**

**1.10 Paying Authority**

DGM I/c (Finance)/HMBP is the paying authority.

**1.11 Submission of the Bills**

Service Provider has to submit his bills in triplicate along with acceptance certificate of quality of radiograph against the order to I/c- CMTU/HMBP duly certified by Executing Authority.

- a) GST Invoice in triplicate
- b) Acceptance of quality of Radiography test by Executing Authority

**1.12 Payments Terms**

- 1 95% payment with 100% tax & duties shall be made within 60 days of receipt of invoice and acceptance of invoice. The firm will submit GST Invoice month wise in triplicate along with Inspection Certificate as per QAP.
- 2 Balance 5% shall be made after completion of the contract.
- 3 Income tax and GST TDS will be deducted by HEC as per Govt. Rule

**1.15 Start of Work**

Firm will take up radiography work within a week after placement of order/ request by I/c-CMTU/HMBP or his representative.

**1.13 Validity of Contract**

This contract will be valid for two years from the date of issue of Letter of Acceptance of the Contract, however the contract can be further be renewed on the same firm on same terms & condition for further two years on mutual consent.

**1.14 Service Provider Responsibility**

1. The radiographic exposed films and reports will be submitted to us and will be the property of HMBP/HEC Ltd Ranchi-4
2. The radiography is to be carried out as per procedure mentioned in ASME Sec. V, Article 2.
3. The Radiographic Testing has to be done by Qualified Persons with atleast RT level -I Certificate by Barc and same has to be submitted at time of Inspection. Test Report must be duly signed along with stamp of Certified Radiographer .
4. All Equipments, unexposed films, developer, fixer and technicians shall be provided by Service Provider.
5. Urgency/Priority of work: - The quantity offered for radiographic is to be attended and completed as per our requirement.
6. Improper quality of radiographs will be re-radio graphed by service Provider free of cost.
7. Quality of Radiography , completion of radiography will be inspected by I/c CMTU/HMBP or his authorized representative.
8. Statutory rules like P.F. deduction, Group Insurance, ESI, Bonus etc. are to be followed.
9. Safety rules to be followed and safety appliances as suggested by HEC safety department is to be provided by the contractor.
10. Workers must be paid in accordance with latest minimum wages act of the Government.

## 1.15 Facilities to be provided by HEC

- Darkroom, Equipment Storage facility, Film cleaning shall be provided by HEC free of cost.
- HEC will allow the service provider and his men inside the work premises from 6:00 AM to 11:00 PM on working days. They can enter or leave work premises during gate opening/ closing time only. However, they may be allowed to work on Sunday / Holidays for only after prior instructions of executing authority duly approved by COP/ HMBP with intimation to I/c-CMTU/HMBP

## 1.16 Termination of Contract.

1. The contract can be terminated if the service Provider fails to complete the work in time and even after giving in writing to him, he does not improve his performance then contract can be terminated.
2. If the Service Provider does not follow statutory rules, safety rules and in spite of giving notice he does not improve.
3. Any other reason due to which company thinks it fit to terminate the contract.
4. In the event of the termination of the contract in part/ full the company can get the work completed from any other agency/ departmentally at the risk and cost of the contractor.

## 1.17 Liquidated Damage

In case of delay in completion of work LD to be levied @ 0.5% of the unfinished part per week of delay subject to maximum deduction of 10% of the contract price.

## 1.18 Arbitration

In case of any dispute in executing of this contract the same to be settled by arbitrator appointed/nominated by chairman-cum Managing Director of HEC Ltd. The decision given by such arbitrator shall be final and binding on both parties i.e. HEC Ltd., and the contractor.

The dispute shall be strictly subject to Ranchi Jurisdiction only.

## 1.19 General Conditions of contract for works contract of HEC Ltd.

The contract will be governed by General conditions of contract for work contract of HEC Ltd., which is available in the website of the company for downloading by the interested tenderer.

## 1.20 Notes

- 1.20.1 Tender shall be prepared by typing or printing on the A4 size sheets in English language only on tenderer letter head and to be submitted in duplicate.
- 1.20.2 The tenderer shall submit signed and stamped copies of all documents regarding eligibility criteria as per clause 1.3.
- 1.20.3 The cover of the envelope should also indicate the name of tenderer and his address. In addition the heading tender opening date and time should be indicated on the left hand corner of the envelope. Any proposal with no indication given on the cover of the envelope to indicate that it is a tender proposal and which if gets opened before the due date and time set for opening shall be liable to be opened and read out. The Tenderer has the option of sending the tender by registered post or submit the proposal in person so as to reach by the date and time indicated in the "Invitation to tender".




