Tender must be submitted in sealed cover in two bid system.

Part-I i.e. Technical bid along with Earnest money in one envelop

Part-II i.e. Price bid in another envelops.

Both envelops should super scribed the tender No. and due date failing which tenders may be ignored.

Opening of tender is on 25.09.2018 at 4.00 PM.

#### Note:

- 1. Offer to be submitted on "as is where is" condition of the Godown.
- 2. The Rental period of 11 months is renewable for further 11 months on mutually agreed terms and conditions (Renewal request to be submitted 45 days before the expiry of the period on application).
- 3. The rent will be increased @10% at the time of renewal and will be applicable.
- 4. Godowns are to be used for storing of materials/goods only. As per the storage of material all the norms prescribed by the State Govt./Central Govt. shall be applicable.
- 5. Rate quoted by the tenderer should be exclusive of taxes. Any tax (if applicable) shall be given extra.
- 6. The rate quoted must be firm and the offers made must remain valid for **three months** from the date of opening of the tender.
- 7. Quotations erased or over written are likely to be rejected unless all corrections are authenticated with the tenderers signature & seal.
- 8. All the particulars i.e. specification, literature, credential or experience of similar works has to be submitted along with the quotation.
- 9. The allottee will have to maintain the Godown in good condition. On the expiry of the period of Rental the allottee has to hand over the Godown to HEC Ltd. on the same condition as it was at the time of allotment.
- 10. The tender shall be subject to the Corporations General Terms & conditions of contract which can be downloaded from our website (www.hecltd.com).

- 11. The allottee shall obtain electric connection (if required) from (Jharkhand Urja Vikas Nigam Limited (JUVNL) and pay the electricity charge directly to JUVNL. They are subject to the rules and regulations of JUVNL as in force from time to time. All dues related to electric connection such as electricity charge should be cleared by the tenderer at the time of handing over of Godown to HEC Ltd.
- 12. The allottee will be liable to pay to HEC Ltd. other charges in respect of the Rental premises on pro-rata basis apart from the Rental fee that may be levied by the State/Central Govt. or any other authority/body authorized on this behalf from time to time.
- 13. This allotment order shall automatically stand terminated on expiry of the period of Rental unless it is renewed by HEC Ltd. at its sole discretion on receipt of application made 45 days prior to the date of expiry of Rental/renewal agreement last granted.
- 14. Payment of Rental Fee: The allottee shall pay the Rental Fee and other charges in advance (i.e. between 25<sup>th</sup> -30<sup>th</sup> of each month), failure of deposit of Rental Fee for 2 consecutive months will lead to cancellation of rental agreement and the Security Deposit will be forfeited.
- 15. The allottee shall not sublet/subrent the Godown. Violation of it shall cause cancellation of Rental and eviction as per the provisions of the law and any amendment thereof.
- 16. The allottee shall not do any kind of extra construction/modification/alteration/encroachment without obtaining prior written permission of HEC Ltd.
- 17. Earnest Money: The tenderer is required to deposit an Earnest Money of Rs. 1,50,000 (Rupees One Lakh Fifty Thousand Only.) through Demand Draft drawn in favour of HEC Ltd., payable at Hatia/Ranchi along with the tender documents. The tender submitted without Earnest Money and above documents will summarily be rejected.
- 18. The applicant will apply for all four nos. of Godowns, considering them as a single unit.
- 19. Security Deposit shall be Rental Fee of 11 months to be deposited by the successful bidder within seven (7) days from the date of Letter Of Intent. The Earnest Money will be adjusted against the security deposit. Security Deposit shall be deposited in the form of Bank Guarantee or Demand Draft.
- 20. No tender shall be accepted after the scheduled date and time of closing.
- 21. The allotment will be made to the competitive highest bidder in "as is where is" condition of the Godown.
- 22. The allottee will have to execute an agreement for 11 (eleven) months on prescribed format by TA Division, HEC Ltd.
- 23. The allottee will have to maintain the area neat & clean himself without any claim from HEC Ltd.
- 24. After the allotment/execution of the agreement, the allottee will have to abide by all the terms & conditions of the allotment and on direction issued from time to time, the violation of which will lead to termination of the agreement. In such case the security deposit amount will be forfeited.
- 25.HEC Ltd. reserves the right either to accept or reject any tender at its sole discretion without assigning any reason whatsoever.
- 26. The decision of the HEC Ltd. regarding allotment of the Godown shall be final and binding which cannot be challenged in any manner, in any court of law.

#### 27. Qualifying Criteria

- The Bidder should have any of the following:-
  - 1. Agency Dealership Certificate
  - 2. Clearing & Forwarding(C&F) Certificate
  - 3. Company Certificate of Registration
  - 4. Proprietorship
  - 5. Firm
  - 6. Society
- The bidder should be existing for minimum 3 years.
- The bidder should have minimum 3 years experience of storing Cement, Grains Pharmacy etc, except hazardous / explosive items. The following documents should be submitted in support of evidence.
  - 1. Audited Balance sheet of last three years
  - 2. PAN
  - 3. IT Returns of last 3 years
  - 4. An affidavit as per Proforma at Annexure-I, for experience in the relevant field for last 3 years.

#### 28. Selection Procedure:

- The selection of the bidder will be made on the basis of the fulfillment of qualifying criterias.
- The bidder who will quote highest rate i.e. H1 bidder (for all four nos. of Godowns, considering them as a single unit) amongst the suitable offers based on the evaluation above will be considered.

#### 29. Dispute Resolution:

The parties to this contract at first instance shall endeavour to settle by mutual discussion all the questions of disputes or differences arising out of, or relating thereto, or in connection with this contract and in the event of failure of settlement, Chairman-cum-Managing Director of the Company (HEC Limited) for adjudication by a Sole Arbitrator, who will not be a regular employee to be appointed by him (CMD of the Company) who (Sole Arbitrator) shall adjudicate the matter in question in accordance with the Arbitration and Conciliation Act 1996 (For short "Act") and publish the award. The parties may mutually be agreed if the Sole Arbitrator so appointed is an ex-employee of HEC Ltd. If the

Sole Arbitrator for any reason, whatsoever, becomes unable to proceed with the arbitration, the Chairman-cum-Managing Director of the company shall appoint his successor arbitrator who may proceed with the reference from the stage it was left by his predecessor subject to the provision of the Act. The venue of the arbitration proceeding shall be at Ranchi in the State of Jharkhand alone.

#### **30. Jurisdiction of Court:**

The Courts of Ranchi at Jharkhand shall have the exclusive jurisdiction for dispute trials, if any, arising out of this agreement between the parties.

#### 32. HEC Ltd. reserves the right to the following:

- a. Reject any or all proposals received in response to the open tender without giving any reason whatsoever.
- b. Extend the time for submission of tender.
- c. Modify the NIT document, by an amendment that would be published on the website.
