TERMS & CONDITIONS:-

1. The bidders who are registered as **Micro/Small/Medium Enterprises** with the prescribed authority under **Micro, Small and Medium Enterprises Development Act, 2006**, are required to submit copy of the registration certificate and indicate **twelve digits Entrepreneur Memorandum Number** along with the **techno-commercial bid (Part-I)**. In case such details are not provided by any bidder, it will be presumed that the bidder is not a **Micro, Small and Medium Enterprise** as per the provision of **Micro, Small and Medium Enterprises Development Act, 2006** and consequently they are not eligible to the benefits admissible under the Act.
2. **EMD** of unsuccessful bidder will be refunded within a reasonable time on the basis of their written request.
3. The quoted price of the bidders must be competitive and unconditional. In case of any discrepancy in rate filed up in words and figures then the value in word will prevail.
4. Bidders are requested to quote their price Exclusive of GST. It is deemed that the bidders are satisfied with their quoted rate for completing the job/supply as per the scope of work/tender schedule. No complaint in this regard shall be entertained later. The bid will remain **valid for 90 (Ninety) Days** from the date of opening of technical bid.

27.PAYMENT TERMS:-

The payment of Bandobasti rent to the HEC would be on monthly basis and paid **strictly before beginning of each month (i.e. by 25th of previous month)**

Note:- (1) Delay in submission of rent may result in penalty i.e 0.5% per week/02% per month.

28. SECURITY DEPOSIT:-

EMD will form as initial security deposit and total **Security Deposit** will be **equal to 3 months Bandobasti rent as in the contract terms**. Total **SD** will be refunded on submission of **work completion certificate** issued by the **executing department** towards successful completion of the work. **EMD/Security Deposit will be forfeited if the contract is terminated for any reason whatsoever.**

29.GOODS & SERVICE TAX (GST):-

Quoted Price of all bidders must be exclusive of **GST** and they are required to indicate **GST** in **percentage (%) or value** separately in their **techno-commercial bid (Part-I)**. Applicable **GST** is payable by the bidder extra.

30.ARBITRATION:-

1.The parties to this contract at the first instance shall endeavor to settle by mutual discussion all the questions of disputes or differences arising out of, or relating thereto, or in connection with this contract.

In the event of failure of settlement, the aggrieved party with prior written permission of other party, shall refer the unresolved dispute(s) or difference(s) to the Chairman-cum-Managing Director of the Company (HEC Limited) for adjudication by a Sole Arbitrator to be appointed by him (CMD of the Company) who (Sole Arbitrator) shall adjudicate the matter in accordance with the Arbitration and Conciliation Act. 1996 (For short "Act") and publish the award.

The parties shall have no objection if the Sole Arbitrator so appointed is an employee or ex-employee of HEC Ltd. , superannuated almost 3 years ago.

If the Sole Arbitrator for any reason, whatsoever, becomes unable to proceed with the arbitration, the Chairman-cum-Managing Director of the company with mutual consent of both the parties, shall appoint his successor arbitrator, who may proceed with the reference from the stage it was left by his predecessor subject to the provisions of the Act. The venue of arbitration proceeding shall be at Ranchi in the State of Jharkhand alone.

The other provisions of Arbitration and conciliation Act 1996(As amended from time to time) shall apply to the arbitration proceedings.
