#### 1.1 Description of work

The work involves surface cleaning of plates, sections and fabricated structures by shot/grit blasting and painting of cleaned surfaces, sections and structures by brush and/or spray with specified/required primer or paint. The work is to be carried out under the technical supervision of HEC Engineers.

#### 1.2 Submission of Tender

The complete tender to be submitted in a separate sealed envelope super scribing the tender no. by 1:00 PM of 02/05/19 in the office of the DGM/ACD, HMBP ADM Building, HEC Ltd, Ranchi -4.

The offer is to be submitted in two parts. Part I and part II.

Part I of the tender will comprise Techno Commercial offer which shall contain / cover all terms and conditions, Earnest money deposit, (Annexure I & II) and one copy of this tender document duly signed on each page. The part I of the tender shall also have the price format (Annexure III) with blocks duly filled as "Quoted" against each head. The taxes & duties should be clearly spelt out in the techno commercial offer (Part - I)

Part-II of the bid will comprise price format (Annexure III) duly filled up by tenderer.

Both the offer as Part-I & Part-II shall be in separate sealed covers clearly super scribing tender reference no. with date & due date of submission and Part I & Part II respectively.

1.8 Security Deposit

Security deposit shall be 10% of the contract value. The SD amount (as retention money) shall be deducted @ 10% from the running bills. In the event of non execution of the contract or withdrawal before expiry of the validity period security deposit will be forfeited.

1.9 Refund of Security Deposit

The security deposit will be refunded within reasonable time of issue of completion certificate against the request of the contractor and no claim certificate from the respective executing department.

1.10 Executing Authority

I/c 041-042, & I/c SFW/HMBP will be the executing authority of the contract and contractor after award of work has to take all necessary working instructions from them only.

1.11 Inspection

Inspection will be done by QCA/HMBP or their representative. QAP (Quality Assurance Programme) whenever required will be given to the contractor.

1.12 Measurement of Work

Contractor has to detail out the method to evaluate the quantum of work done using physical parameters and to be duly recorded in Measurement Book. Depending on work, time frame may be indicated against successive quantum of task.

1.13 Paying Authority: DGM I/c (Finance)/HMBP

1.14 Liquidated Damage

In case of delay in completion of work LD to be levied @ 0.5% of the unfinished part per week of delay subject to maximum deduction of 10% of the contract price.

1.15 Submission of Bills

Contractor has to submit his bills in triplicate along with following documents once in a month to DGM/ACD/HMBP duly certified by I/c 041-042 Shop/ HMBP or I/c / SFW shop/ HMBP..

- a) Running Account bill duly verified by Shop/HMBP

- c) Measurement book submitted

#### 1.16 Payments Terms

Contractor can claim payment for the value of work done at the end of every month. TDS shall be deducted as per rule.

1.17 Arbitration

In case of any dispute in executing of this contract the same to be settled by arbitrator appointed/nominated by chairman-cum Managing Director of HEC Ltd as per the clause mentioned in the General Conditions of Contract for works Contracts of HEC Ltd. The decision given by such arbitrator shall be final and binding on both parties i.e. HEC Ltd. and the contractor.

1.18 Start of Work

The successful tenderer shall start the work within 2 weeks of issue of Letter of Award of the Work Order. The contractor will meet the executing authority for taking possession of working area in the shop.

1.19 Validity of the contract

Validity of contract will be one year from the date of issue of LOA/ Work Order i.e. contract period of the gang shall be one year with a provision of extension on satisfactory performance and mutual agreement.

#### 1.20 Contractor's Responsibility

- 1.20.1 Plant and Equipments to be arranged by contractor
  - (a) Compressor and necessary accessories such as valves hoses etc.
  - (b) Safety equipments/ dresses such as masks, eye protective etc., for the employee of the contractors.
  - (c) Short/Grit Blasting Equipments.
  - (d) Painting equipments such as spray Machine, Painting Brushes etc.
  - (e) The consumable such as shots and Girt.
- 1.20.2 After Shot Blasting the blasted surface will be put up to HMBP inspection in writing for obtaining the clearance from QCA. The primer painting will be carried out which will be passed finally by QCA/HMBP or his authorized inspector.

- 1.20.3 The primer paint, Thinner, crane handling, power and water will be provided free of cost by HEC. However manual handling/ handling inside the chamber is to be done by contractor.
- 1.20.4 Statutory rules like P.F. deduction, Group insurance, ESI etc. to be followed by the contractor.
- 1.20.5 Contractors who have been awarded works contracts should have EPF code number.
- 1.20.6 In case the contractor has his own EPF Code given by RPFC, then in that case he should deposit the contribution of his workmen against their UAN no every month and will submit a copy of the challan in this regards along with his bills to the concerned finance deptt.
- 1.20.7 Safety rules to be followed and safety appliances as suggested by HEC Safety department is to be provided by the contractor to their workmen.
- 1.20.8 Workers must be paid in accordance with minimum wages act Of the Government. Bank A/c of each and every persons working under the tenderer should have individual bank account.

## 1.21 Facilities to be provided by HEC

- 1.21.1 Free supply of power and water etc. required to perform the specified work. .
- 1.21.2 Space required for storage cum office will be provided at work site by HEC.
- 1.21.3 HEC will allow the contractor and his men inside the work premises in all the three shifts on working days. They can enter or leave work premises during gate opening/ closing time only. However they may be allowed to work on Sunday/ holiday only after prior instructions of executing authority duly approved by COP/ HMBP.
- 1.21.4 Providing canteen facility of food and snacks at par with HEC employees.

#### 1.22 Agreement

The Successful tenderers shall be required to enter into an agreement with the company on non-judicial stamp paper of requisite value. The General and special condition of contract along with this tender document will form part of agreement.

#### 1.23 Termination of Contract.

1.23.1 The contract can be terminated if the contractor fails to perform the work assigned in time and even after giving in writing to him, he does not improve his performance then contract can be terminated.
