# **Technical Specification**

## 1. The specification of vehicle as follows:-

- a) Vehicle type:- SUV(Bolero/ equivalent)
- b) Usage variant:-3000km / month
- c) Type of service:-Local /outstation(if required)
- d) Year of vehicle Model:-2018-2023
- e) KM travelled :- upto 100000 km
- f) Outstation / night charge/overstaying as applicable

## 2. Working Hours

• 12 hours in a day will be considered as a normal duty hours and normal working hour will be 8:00 am to 8:00 pm.

## 3. Validity of order

The period of order will be for a period of 05 (five) months commencing from the date of e ngagement of vehicle at Site. The vehicle must be engaged within 02 days of placement of order. The order can be extended further on the basis of mutual consent of both parties de pending on our requirement of vehicle at site.

- **4**. Depending upon our requirement of vehicle, if an extra vehicle is required to be hired for maintaining the smooth functioning of site activities the same could be hired from the same agency at same rate and Terms & Conditions on the basis of mutual consent.
- **5**. The agency has to maintain proper daily LOG BOOK of the vehicle duly signed by officers of HEC.
- **6**. The alternate SUNDAY shall be allowed as OFF day for the maintenance of vehicle. (Two Sunday's in a month only).

## **Special Instructions to tenderers:**

- a) Signed copy of Registration Certificate of the vehicles must be attached with the quo tation.
- b) Signed Copies of GST Registration Certificate and PAN Card must be attached with th e quotation.
- c) Tenderer must have experience of providing vehicle hiring service to Govt. organizati on/PSU/reputed private institutions. Tenderer must submit one PO copy as proof of sa

me.

- d) The vehicles will have all the statutory papers, duly updated, to facilitate smooth entry into BCCL and other local sites/places as per instructions of Site (I/c)/MW.
- e) During vehicle movement, if any statutory penalty is levied by the statutory body est ablished by the Government due to shortfall of statutory compliances, the same will be borne by the agency.
- f) All taxes, insurance and statutory liabilities shall be borne by the agency. Toll Tax levi ed by statutory authority shall be reimbursed to the successful bidder. The toll tax has to be certified by officer of HEC.
- g) Diesel and Engine Oil for the vehicle will be arranged by the agency.
- h) Any maintenance required for the smooth and trouble free running of vehicle shall be done at no extra cost.
- i) Driver will be well dressed, soft spoken and well disciplined with proper driving licens e. HEC's requirements for vehicle will be throughout the week including Holidays & Sundays except alternate Sundays, which will be OFF DAY for the maintenance purpo se of the vehicle. The driver will report to duty with his Tiffin (Lunch arrangement) so that the vehicle is available for use of HEC as and when need occurs.
- j) The first rental will be calculated on Pro- Rata basis i.e. from the date of actual deplo yment of vehicle in the first English calendar month.
- k) Vehicle not be more than 05 years old is preferable.
- In case successful bidder fails to provide vehicle due to any reason like breakdown, u
  navailability of driver etc for a particular period of time, HEC will have right to hire an
  other vehicle and extra cost thus incurred will be recovered from the bills/ SD of succ
  essful bidder.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
