Any equipment, rating of the equipment, type number of the equipment has to be modified/newly incorporated in the BOM for the successful Interfacing/commissioning of the Drive package according to the functional requirement of the Center lathe has to be incorporated in the submitted BOM only after discussing with M/s HEC Limited.
