1.0 SCOPE OF WORK & SUPPLY:-

A. Scope of work for MCT platform extension in 150+30T NSY, crane (DSP, Durgapur)

- 1. Extension of platform as per drawing SK 3200.02.221-02 nos, SK 300.02.222-02 nos, SK 3200.02.223-02nos for both the cranes.
- 2. All welding should be done properly. Sufficient accessibility /approach to be ensured for all welding.
- 3. Use electrode as per IS 814-91 coding ER4211.
- 4. Plate (for toe guard) is to be suitability cut/shifted to suit the site condition for placing new items.
- 5. Repositioning of limit switches and MCT buffer to maximize hook approach.
- 6. Measurement of hook approach before and after modification work.
- 7. 08 nos of Plate 190x130x36 (drg no. 3720.17.204) required for packing under buffer.

B. Scope of work for ACT platform extension in 150+30T NSY, crane (DSP, Durgapur)

- 1. Extension of platform as per drawing SK 3200.02.225-02 nos both the cranes.

E. Scope of work for bracket for cable entry on main trolley of 150+30T NSY, crane (DSP, Durgapur)

Front part of Bracket for cable entry for festoon cable was damaged during operation by DSP Durgapur. The bracket structure shall be fabricated at HEC, Ranchi and supplied to DSP Durgapur. Scope of work at site will include.

- (a) Removal of damaged bracket.
- (b) Strengthening of Mast stand with proper welding at bottom part connecting trolley.
- (c) Erection of bracket supplied by HEC at site (Drg no. 3719.75.120)
- (d) Redressing of cables in presence of site engineer (electrical).
- (e) Re-looping of cables if required.
- (f) Work shall be carried out for one crane only.
