Offers to be submitted in two parts.

You are requested to submit your quotation in TWO BID system i.e Part-I: Techno-commercial bid, Part-II: Price Bid.

01.Techno-commercial Bid

The Techno-commerical bid should contain the un-priced schedule of items, Catalogue, Payment terms and conditions, Taxes & Duties, delivery time, authorized dealer etc.

02. Price Bid

Price Bid indicating prices and other commercial terms i.e. discount against catalogue price of each item, taxes & duties etc.

Both above bid i.e. Techno-commercial Bid & Price Bid must be kept in separate sealed cover.

- (a) Techno-commercial bid, LTE No.and due date of opening must be indicated on the top of the Techno-commercial bid cover.
- (b) Price bid, LTE No. and due date of opening must be indicated on the top of Price Bid cover.

03. EMD

Earnest Money in separate sealed envelope super scribing EMD on it without mentioning the amount of EMD on the envelope. The amount of EMD is not to be written anywhere in the Technical bid, otherwise that tender will be treated as invalid tender. Only DD No. is to be mentioned in the technical bid and envelope also. Without EMD firms tender will not be Considered.

Above three sealed envelope must be put in another sealed cover. Following are to be indicated on the top of this cover.

- (i) Whether Techno-commercial Bid enclosed or not.
- (ii) Whether Price Bid enclosed or not.
- (iii) EMD in separate sealed envelope enclosed or not.
- (iv) LTE No. & Date
- (v) Due date of opening

Special condition if any:

NOTE

- 1. The rate quoted shall be inclusive of all packing & forwarding. Freight charges to be mentioned separately.
- 2. The Price quoted by the tenderer should be exclusive of sales tax. The rate and nature of sales tax applicable should be shown separately. Sales tax will be paid to the seller at the rate at which it is liable to be assessed or has actually been assessed on the date of supply provided the transaction of sale is legally liable to sales tax and within the delivery period. Any change on the taxes & duty structure beyond the delivery period will not be considered by HEC.
- 3. The rates quoted must be firm and the offers made must remain open for acceptance for three months from the

- date of opening of the tender.
- 4. Quotations erased or over written are likely to be rejected unless all corrections are authenticated with the tenderer's signature.
- 5. Delivery date offered must be specified and guaranteed.
- 6. Full payment will be made after 30 days of the receipt of supplies at destination duly inspected.
- 7. Full particulars i.e. specification, literature and / or drawing wherever applicable should be submitted alongwith the quotation. The brand and 'Make' name must be Indicated.
- 8. The Corporation does not pledge itself to accept the lowest or any tender and reserves to itself the right of accepting the whole or any part of tender or portion of the quantity offered and you shall supply the same at the rate quoted.
- 9. Supplies will be subject to Inspection by our Inspection wing / or inspection agencies prescribed by

Corporation reserves the right to call for and examine at any time the books of accounts and other documents and papers of the firm for the purpose of ascertaining whether any excess payments has been made or the firm likely to be received / received undue benefit out of execution of the particular contract.
- 12. Earnest Money (if indicated above specifically) Earnest money to the extent of 2% of the total value will have to be deposited by demand draft on the State Bank of India, Ranchi Hatia Branch, in favour of Heavy Engineering Corporation Ltd. Ranchi.- 4
