Terms & conditions:

- 1. The rate quoted shall be inclusive of all packing & forwarding. Freight charges to be mentioned separately.
- 2. The Price quoted by the tenderer should be exclusive of sales tax. The rate and nature of sales tax applicable should be shown separately. Sales tax will be paid to the seller at the rate at which it is liable to be assessed or has actually been assessed on the date of supply provided the transaction of sale is legally liable to sales tax and within the delivery period. Any change on the taxes & duty structure beyond the delivery period will not be considered by HEC.
- 3. The rates quoted must be firm and the offers made must remain open for acceptance for three months from the date of opening of the tender. Variable price or price variation clause shall not be accepted in any case. Firms offers with price variation clause will not be considered.
- 4. Unpriced scheduled (blank price format) of items considered in line with scope of supply of tender enquiry shall be furnished alongwith techno-commercial bid.
- 5. Quotations erased or over written are likely to be rejected unless all corrections are authenticated with the tenderer's signature.

- 6. Delivery date offered must be specified and guaranteed.
- 7. Payment terms :100% of the total contract value alongwith 100% taxes and duties shall be released through cheque within 30 days of the receipt of materials complete in all respect alongwith GC,TC, IC, EDGP and original invoice.
- 8. Full particulars i.e. specification, literature and / or drawing wherever applicable should be submitted alongwith the quotation. The brand and 'Make' name must be Indicated.

- b) The purchaser may procure the undelivered stores / similar items from elsewhere, without notice to the contractor at the risk of the contractor without canceling the contract in respect of the consignment not yet due for delivery or,
- c) to cancel the contract or a portion thereof.
- 16. Copy of Permanent Account No. (PAN) (of Income Tax) to be enclosed with the bid.

Ultrasonic position sensor having sensing range 0 to 1000 mm and analog output 4 - 20 mA in IP65 protection. The position sensor shall be suitable for 50° C ambient.

The sensor shall comprise of the following:-

- a) Ultrasonic sensor, range 0 to 1000 mm.
- b) Connector switch with 10 meter cable.
- c) Programming cable for sensor
- d) Software for parameterization of sensor through PLC.
- e) Junction Box, 200 mm X 100 mm X 100 mm made of cold rolled steel sheet of thickness 2 mm with suitable gland plate of thickness 3 mm in IP65 enclosure. The Junction Box shall house SMPS power pack suitable for 110V AC input & 24V, 3A DC output. The SMPS shall be suitable for power supply to ultrasonic sensor. Sufficient nos. of terminal block shall also be provided in the Junction Box.
- f) Firm should also furnish details of connecting cables with rate per meter length.

Note:-

- 1) Firm to furnish details of target with material.
- 2) Dimensional drawings of ultrasonic sensor, connector & junction box with mounting details.
- 3) Firm should confirm that 4-20mA analog output of ultrasonic sensor shall be transmitted to analog input module of PLC at a distance of 500 meter.
- 4) Firm to confirm that ultrasonic position sensor shall be suitable for excessive dusty environment. The environment may also contain suspended grease particle.
- 5) Inspection & Testing

Approved Quality Assurance Plan (QAP) shall be adhered to for any manufacturing/ testing / inspection of the Ultrasonic sensor. The inspection shall be carried out by HEC / L&T/ Client's representative.

• Type Test and routine test reports for all the equipments & accessories covered under bidder's scope of supply shall be submitted.

6) Performance Guarantee

Bidder / vendor shall guarantee that the equipment offered shall meet the performance requirement. In case the system is not able to meet desired performance. the bidder shall rectify / replace it to the satisfaction of HEC / L&T/ CMPDI without any cost implication.
