- (a) Bearings should be free from any kind of rust
- (b) Body of the bearing / surface finish should be good.
- (c) Wrappers used for packing of bearings should be original.
- (d) Cage design and the materials should be strictly as per specification given in the purchase order.
- (e) Radial play of the bearings should be as far as practicable measured & recorded.
- (f) Monogram markings used should be original.
- (g) Hardness of outer race should be between 60 to 65 HRc.

NOTE:

- 1. The rate quoted shall be inclusive of all packing & forwarding. Freight charges to be mentioned separately.
