- (a) Bearings should be free from any kind of rust*
- (b) Body of the bearing / surface finish should be good.*
- (c) Wrappers used for packing of bearings should be original.*
- (d) Cage design and the materials should be strictly as per specification given in the purchase order.*
- (e) Radial play of the bearings should be as far as practicable measured & recorded.*
- (f) Monogram markings used should be original.*
- (g) Hardness of outer race should be between 60 to 65 HRC.*

NOTE:

1. The rate quoted shall be inclusive of all packing & forwarding. Freight charges to be mentioned separately(if any).
2. The Price quoted by the tenderer should be exclusive of sales tax. The rate and nature of sales tax applicable should be shown separately.
