CONDITIONS OF SUPPLY OF TUBES AND HOLLOW SECTIONS

1. Hollow sections to be externally coated with anti-corrosive paints as protection against rust during sea voyage.
2. Internal bores / Surfaces to be free from rust/scales.
3. Tolerance on length must be on plus side (upto +3%). Shorter length pipe not acceptable.
4. Ends of the section to be covered / capped for protection.
5. Tolerance on diameter & other supply conditions to be as per BS: 3602.
6. Dimensional tolerance as well as other supply conditions for Hollow Sections to be as per BS:4848(part-II) of 1975.
7. For material Gr.50E to BS:4360-79 should ensure impact of 41 jules at - 30°C.

14. **Risk purchase clause:** If the material is not supplied as per the delivery schedule in the purchase order then order may be cancelled and material can be procured at the risk and cost of the firm.
