Method of submission of offer

The offer has to be given in two parts. 1st part will contain information as asked in part-I of the enquiry. This Part-I should be kept in one envelope and super scribe name of the enquiry and Part-I over the envelope. Part-II of the offer will contain price bid only which is to be given in the format as given as Part-II of the enquiry. This price bid should be kept in a separate envelope and super scribe name of the enquiry and Part-II over the envelope both the sealed envelope should be kept in one single envelope and super scribe name of the enquiry and opening date over this envelope also mention part I & II over this envelope. The completed offer must reach us on or before 21/02/2010 at 2:30 PM.

Part (I) and Part (II) should be strictly submitted in the format as given in this enquiry as Annexure – 1 and Annexure – 2 respectively. NOTE:-

- The surface should be smooth and there must be no dents on it. Slabs bending must be done through rolling only. Bending by forging or hammering will not be accepted.
- 2. Price Bid should contain only rates and tax schedule. Rest all the details must be specified and supplied in the techno commercial offer.
- 3. The rate quoted shall be inclusive of all packing & forwarding. Freight charges to be mentioned separately.
- 4. Price should be quoted FOR HMB Ranchi however if not possible then price Ex works /Ex Go Down & freight to be quoted separately .
- 5. The price quoted by the tenderer should be exclusive of sales Tax. The rate and nature of sales tax applicable should be shown separately. Sales Tax will be paid to the seller at the rate at which it is liable to be assessed or has actually been assessed on the date of supply provided the transaction of sale is legally liable to sales Tax and within the delivery period. - 12. Security Deposit In the event of the contract materializing, successful tenderers will have to deposit security equal to 5% of the value of the contract within the desired period. Failing this the contract will be cancelled at the risk and expenses of suppliers. This will be in addition to other remedies available to the purchaser for the successful completion of contract as provided in general terms and condition of the contract of the corporation.

 - b. The purchaser may procure the undelivered stores/ similar items from elsewhere, without notice to the contractor at the risk of the contractor without canceling the contract in respect of the consignment not yet due for delivery or
 - c. To cancel the contract or a portion thereof.
