- (b) Body of the bearing / surface finish should be good.
- (c) Wrappers used for packing of bearings should be original.
- (d) Cage design and the materials should be strictly as per specification given in the purchase order
- (e) Radial play of the bearings should be as far as practicable measured & recorded.
- (f) Monogram markings used should be original.
- (g) Hardness of outer race should be between 60 to 65 HRc.


Otherwise:
