36. **PAYMENT TERM:-** Payment will be made as per following terms:-
- Payment will be made through cheque against submission of signed copy of **Proforma Invoice (PI)** in advance by you before your scheduled PPM/Calibration visit to carry out the subject work.
  - Cheque will be prepared on the basis of signed copy of **PI** and scan copy of the cheque will be sent to you prior planning to your service engineer's every preventive maintenance visit at **FFP/HEC** site.
  - The original cheque will be handed over to your service engineer after completion of work of every preventive maintenance visit against submission of **GST invoice** and **acceptance of executing department towards successful completion of the work of every preventive maintenance visit.**
37. **INCOME TAX DEDUCTIONS:-** It will be deducted as per the prevailing rule.
38. **GOODS & SERVICE TAX (GST):-**  
Price of the firm must be exclusive of **GST** and they are required to indicate **GST in percentage (%) or value** separately in their **techno-commercial bid (Part-I)**. Applicable **GST** is payable to **the firm** extra. Payment of **GST** will be made to **the firm** on the basis of timely submission of **GST invoice** as per **GST rule** and submission of all documents as per **payment terms**. 39. **LD CLAUSE:-**  
If the **firm** fails to visit scheduled **three times** within the contract period, **LD** will be levied @ $\frac{1}{2}$ % of total contract value per less visits subject to a maximum **10%** of total contract value.
40. **AGREEMENT:-**  
An agreement will be signed between HEC & the firm within **30 days** from the date of issue of the work order on **Non-Judicial Stamp Paper of requisite value** as per provision of Indian Stamp Act. on the Performa prescribed by HEC Ltd. available on **Contract Cell/FFP**. The General Condition of Contract alongwith Work Order and the Tender Document will be the part of Agreement and binding on the firm. Unless and until agreement is prepared and executed, the **Acceptance Letter Cum Work Order** shall be deemed as an agreement of this contract between **HEC** & the firm.
41. **ARBITRATION:-**  
Normally all disputes should be settled by negotiations between the company and the firm. In case any dispute/difference is not settled through negotiations, the firm can seek remedy by arbitration by invoking the same within **120 days** of dispute.
- The Arbitrator (s) will be appointed to resolve the disputes between the parties. The CMD of HEC Ltd. is having absolute power to appoint a single Arbitrator or more than one Arbitrator or to refer the dispute to the Institutional Arbitration at his discretion and his decision is final and binding on the firm. The appointed Arbitrator(s) / Institutional Arbitration should pass a reasoned award and the firm should bear the costs of the Arbitration equally.
  - If any of the Arbitrators appointed by the CMD of HEC Ltd. is unable to continue as an Arbitrator for any reasons whatsoever or if the CMD of HEC Ltd. for the reasons to be recorded in writing thinks fit for appointment of a new Arbitrator in the place of existing Arbitrator, he is having a power to do so. If such a new Arbitrator is appointed, he can either continue the arbitration proceedings from the stage where the earlier Arbitrator discontinued his proceedings or alternatively the new Arbitrator may start proceedings *de novo* if the circumstances warrant him to do so.
- Failing to invoke Arbitration clause within **120 days** of dispute, the matter is to be decided by **Civil Courts at Ranchi, Jharkhand** state alone and not at any other place.

- b) If the firm fails to satisfy the executing dept. with progress of the job.
- c) If any act of malpractices likes pilferage, corruption, harming/misusing company's property, ill- treating company's employee or any one related to the company by the firm or his deployed workman including supervisor at any stage of the contract is detected.
