Technical requirements:-

- 1. Dimensions & material specifications:- Strictly as per drawings.
- 2. ID Tolerances: ID tolerance of moulds shall be as per drawing i.e. ±1 (one) mm and the internal surface shall be as per cast and truely cylindrical.
- 3. All instructions given in the drawing are to be strictly adhered to.
- 4. Inspection: At FFP/HEC, Ranchi.
- 5. Procedure for inspection & acceptance of cylindrical moulds for loco wheels is stipulated as under:
