Method of submission of offer:

The complete tender is to be submitted in a separate sealed envelope super scribing the tender no., before the scheduled date of submission of tender in the tender box at the office of ACD/ HMBP, Room no. 28, HMBP ADM Building, HEC Ltd, Ranchi 4. If the tender is bulky & voluminous the tenders are to be submitted at office of MM/HMBP.

The offer has to be given in **two part bids**. **Part-1 of the offer will contain the technical and commercial aspects** as asked in part-I of the enquiry. This Part-I should be kept in one envelope and super scribe name of the enquiry and Techno-Commercial Bid Part-I over the envelope. **Part-II of the offer will contain Price Bid** which is to be given in the format as given in Part-II of the enquiry. This price bid should be kept in a separate envelope and super scribe name of the enquiry and Price Bid Part-II over the envelope. Both the sealed envelopes should be kept in one single envelope and super scribe name of the enquiry and opening date over this envelope also mention part I & II over this envelope. The completed offer must reach us on or before **15/07/2019 upto 1.00 PM**.

Part (I) and Part (II) should be strictly submitted in the format as given in this enquiry as Annexure – 1 and Annexure – 2 respectively.

Qualifying Criteria:

1. **Validity of offer** should be minimum 90 days from the date of opening of tender. The offer with a lower validity period other than 90 days will not be acceptable and such offer shall be ignored without assigning any reason.

Terms & Conditions:-

- 1. The offer has to be quoted exactly as per the detailed specification.
- 2. The rate quoted shall be **F.O.R HMBP** (inclusive of packing & forwarding, Freight charges & transit Insurance).
- 3. The Price quoted by the tenderer should be exclusive of GST. The rate and nature of GST applicable should be shown separately. GST will be paid to the seller at the rate at which it is liable to be assessed or has actually been assessed on the date of supply provided the transaction of sale is legally liable to GST and within the delivery period.
- 4. Payment Term- Actual payment to be made directly by the patient to the testing lab, which is reimbursable as per HEC policy on approved rates.
- 5. Delivery Service to be rendered within 3 months of prescription/refereed patients.
- 6. Validity of rate contract: Three years from the date of issue of contract.
- 7. The corporation does not pledge itself to accept the lowest or any tender and reserves to itself the right of accepting the whole or any part of tender or portion of the quantity offered and you shall supply the same at the rate quoted.
- 8. Order placed as a result of this tender will be subject to the Corporation's General Terms and Conditions of contract which can be down loaded from our website (www.hecltd.com).
- 9. Corporation reserves the right to call for and examine at any time the books of accounts and other documents and papers of the firm for the purpose of ascertaining whether any excess payments has been made or the firm likely to be received / received undue benefit out of execution of the particular contract.
- 10. The final quantity may vary at the time of finalization of tender; however the proper clarification / confirmation shall be taken from the firms.
- 11. Tenderers registered with National Small Industries Corporation/ Small Scale Industries/ Micro, Small scale Industry (MSE) for the tendered item will be exempted from submission of EMD. The tenderer should enclose an authenticated copy / notarized copy of their valid registration

certificate with MSE/ NSIC for grant of exemption. In case Bidder is covered under MSME criteria, it is mandatory to quote UAM no in Bid Documents.

- **12. Security Deposit:** 5% of the PO value to be deposited by the successful bidder within 21 days after placement of order by HEC which shall remain with HEC till the completion of order by the firm. This clause is mandatory and has to be accepted by all bidders. If security deposit clause is not accepted then the offer of the bidder shall not be considered.
- 13. Based on HEC's requirement and in order to ensure security of supply from more than one sources, the total tendered quantity of any item may be split amongst more than one successful bidders at L1 Landed price. Hence Purchase Order may be placed on more than one firms and the repeat order for 100% quantity may be placed on successful bidder.
- 14. There is no obligation on our part to accept delayed / late tenders. Tenders received after the due date of opening are liable to be summarily rejected.
- 15. **ARBITRATION**-In the event of any dispute or difference of opinion between the Heavy Engineering Corporation or any of its units / division and the contractors as to the respective rights and obligation of the parties hereafter or to the true intent and meaning of these presents and the many articles of conditions thereto, such dispute of difference of opinion shall be referred to the many articles of conditions thereto, such dispute of difference of opinion shall be referred to the sole arbitration of the Chairman, Heavy Engineering Corporation and his decision shall be final, conclusive and binding on the parties.
