The Part I & II offers shall be in separate sealed covers, superscribing on the Top of each envelope relevant Part No.-Description alongwith tender reference no. and date of opening. - 2. Rate to be Quoted on FOR destination i.e. HMBP Store, Ranchi basis only. Freight charge is to be borne by the supplier.
- 3. The applicable rate of excise duty on the date of submission of offer should be clearly indicated, if excise duty is not applicable or Nil it should be clearly mentioned in the offer. Confirm whether EDGP will be provided or not for availing CENVAT, if ED is applicable.
- 4. Firm delivery: In days/weeks/months to be clearly mentioned. Please note that delivery term offer with "Ex stock "is not acceptable.

- 8. EMD (Earnest Money ) is to be submitted along with the offer in separate sealed envelope super scribing EMD, on it without mentioning the amount of EMD on the envelope. The amount of EMD is not to be written anywhere in the Technical bid, otherwise that tender will be treated as invalid tender. Only DD No, is to be mentioned in the technical bid and on the envelope also. The tenderers are instructed to clearly super scribe on the top of the envelope the relevant part number and description along with tender reference number and date of opening. Without EMD, firms tender will not be considered.
- 9. Time and date of receipt of Tender is 12.09.2011 upto 1.00 PM in the office of MM Division, HMBP. Ranchi during working hours. Opening of Tender is on 12.09.2011 at 3.00PM TENDERS must be submitted in sealed cover with Tender No. and the Due date of opening super scribed on it failing which Tenders may be ignored.
